1 AIRPORT CHARGES

The airport passenger boarding, landing, take-off and parking charges, and any other charge determined by the Italian Government are updated annually by a Ministerial decree, containing the review of the charges for every Italian airport and it is published in the Official Gazette of the Italian Republic. Once in force, they are also available at the official website of Bolzano Airport

www.bolzanoairport.it.

All the amounts are displayed in Euro (€) and are VAT exempt.

2 HANDLING

2.1 Handling fees and services

The fees applied by the Management Company and certified Handler ABD AIRPORT SPA are approved by the Italian Civil Aviation Authority ENAC with the document ENAC-PROT-29/03/2022-0037541-P.

All the amounts are displayed in Euro (€) and are VAT exempt.

The Handling fees are based on the maximum take-off weight (MTOW) resulting from the aircraft airworthiness certification, rounded up to the higher ton, regardless of use of the services.



2.2 Basic Handling Fees applied for Commercial Aviation (AOC holders)

Basic fee per ton served, related to MTOW

€ 40,45

List of services included in the handling fee above:

- a) Check-in and passengers boarding
- b) Assistance of arriving/transit passenger
- c) Sorting of baggage
- d) Load control and load-sheet
- e) Airport information
- f) Coordination of airport operations
- g) Assistance for aircraft parking

The individual activities will be performed in accordance with the entries set out in Annex B of the SGHA IATA ed. 2018.



2.3 <u>Optional services</u> handling fee applied for Commercial Aviation– Scheduled or Charter Flights (AOC Holders)

Fee per ton served, related to MTOW

€ 37,37

List of services included in the handling fee above, if purchased all at once:

- a) Lost & Found
- b) Communications
- c) Flight documentation
- d) Water service (nonpotable)
- e) Toilet service
- f) Aircraft loading
- g) Aircraft unloading
- h) Standard interior cleaning

The individual activities will be performed in accordance with the entries set out in Annex B of the SGHA IATA ed. 2018.

The above services can be requested individually and in this case the related fee are defined below:

- a) Lost & Found 100,00€
- b) Communications 55,00€
- c) Flight documentation 60,00€
- d) Water service (nonpotable) 60,00€
- e) Toilet service 60,00€
- f) Aircraft loading 100,00€
- g) Aircraft unloading 100,00€
- h) Standard interior cleaning 230,00€



2.4 Basic Handling Fees for General Aviation -Private Flights – NCC and NCO Operators

Fee per ton served, related to MTOW

€ 15,23

List of handling services included:

- a) Aircraft Parking assistance
- b) Information services
- c) Airport coordination



2 EXEMTIONS AND REDUCTIONS

2.1 Reduction on the basic handling fee for Commercial Aviation, applied to scheduled flights and charter flights only.

The standard fee of the handling services provided "partially" will be **reduced by 50%**.

Services provided "partially" are defined as the handling services performed in the following situations:

- Flight scheduled and then cancelled
- Positioning flight (ferry in/out/both)
- Training flight
- Technical flight

2.2 Handling Services discounted rates for business development goals

Operators, who foresee continuous activities and sustained passenger and business traffic volumes over time or who would carry out policies aimed at benefiting the airport and the tourism of the surrounding region by improving its external links with scheduled or charter flights or by configuring themselves as frequent users of the airport leading to tangible benefits to the local economy, are entitled to special fares or incentive pricing policies.

ABD Airport, however, reserves the right to suspend or not to apply above mentioned discounted rates to operators who have outstanding amounts with the Management Company.

2.3 Handling for General Aviation Aircafts MTOW ≤ 2 tons on "grass apron"

The standard handling fee will not be applied to General Aviation Aircrafts (NCC and NCO) with maximum takeoff weight (MTOW) less than or equal to 2 tons if they are parked on GRASS APRON (Apron 300).



2.4 Handling for Official, emergency humanitarian, military flights and Aeroclub.

The standard handling fee will not be applied to Official, emergency humanitarian, military flights (and similar) if they do not require any assistance and the standard handling fee will not be applied to the Aeroclub Aircrafts during the training activities.

Aeroclub flights and/or based in Bolzano are governed by a special agreement.
